On **Monday 15th September** we are running our September ePEP and Designated teacher training. If you are a Designated Teacher for STATUTORY AGED children we would strongly encourage you to attend this training. Post-16/UASC training will be running on other dates.

A PEP is a **statutory requirement** to ensure that a record is maintained regarding the child's educational progress and thus it forms an integral part of the child's overall care plan.

We have made many changes to ePEP over the summer to try to capture the child's voice in a more succinct way but also to try and make the process more slim lined for our Designated Teachers.

The training is virtual and we look forward to welcoming new and 'old' faces on Monday 15th September at 3.30pm. If you are unable to attend but would like to attend training please contact Jenny.

Extension to the virtual school role: Children in Kinship Care

From September 2024 the non-statutory role of the virtual school was extended to include a strategic responsibility for children in kinship care. Research has shown that children who grow up in kinship care have better outcomes than children who grow up in other types of non-parental care, however their outcomes still fall behind those children with no social worker involvement. This is an exciting development to our work as it will allow us to support a wider group of young people to meet their full potential.

The types of activities that this extension to duty could include are:

- Raising awareness of the needs and disadvantage of children in different types of kinship care arrangements.
- Promoting practice that supports attendance and engagement of kinship children in education
- Promoting practice that improves the educational attainment of children in kinship care
- Providing advice and information to kinship carers with special guardianship orders and child arrangements orders


