Under the new Ofsted framework, inspectors are keen to see certification for the training of a designated teacher. You may have attended National College training or other relevant training for the Designated Teacher and have certification through that CPD course.

If you have attended Wokingham Virtual School Designated Teacher training since September 2024 you should have received a certificate which includes all that was covered within our training. If you would like to attend our training, please do get in touch and we will look to ensure that we deliver this to you in a timely manner so that you have evidence of attending training.



A Quick Designated Teacher Checklist

- **Appointment**

Governing body must appoint a **qualified teacher** (or headteacher) as the Designated Teacher.

This is a legal requirement under the Children and Young Persons Act 2008 and the 2009 Regulations.

- **Core Duties**

Ensure every looked after child has a **Personal Education Plan (PEP)** that is up to date and effective.

Work with the Virtual School Head, social workers, carers, and parents to support the child's education.

Monitor progress, attainment, attendance, and well-being of looked after and previously looked after children.

Report regularly to the governing body on outcomes for these pupils.

- **Who are DTs responsible for?**

Children currently looked after by a local authority.

Children who were previously looked after but are now under adoption, special guardianship, or child arrangements orders.

- **Training and Awareness**

Must undertake appropriate training.

Ensure all staff understand the needs of looked after and previously looked after children.

- **Governance**

Must hold the school accountable for the progress of looked after children.
